SPORTS INJURY CLAIMS PROCEDURE

1. When Injured, report your Injury to your Association immediately.
2. Request a Claim Form from Sportscover within 30 days

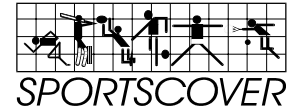

3. Complete and return the claim form to Sportscover within 90 days.
 - Ensure your team, local association and state are provided.
 - Please remember to complete **all** sections to avoid delay.
4. Get your medical practitioner to fill in the appropriate statement.
5. Claim from your Private Health insurer / Medicare, if applicable.
6. When Treatment is complete please return all Accounts to Sportscover.

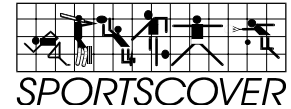


AUSTRALIAN TOUCH ASSOCIATION SPORTS INJURY BENEFITS

NON MEDICARE MEDICAL
<p>The percentage of the expenses covered under this section is 75%</p> <p>The percentage of physiotherapy expenses covered under this section is 75%</p> <p>The excess applicable to the non Medicare medical expenses section is \$100. However, under certain circumstances if you hold Private Health insurance the excess may reduce to nil.</p> <p>The maximum amount payable per claim under this section is \$ 3000</p> <p>Benefit period is 12 months from the date of the injury</p> <p><i>**Please note After six visits to an ancillary provider a referral from a legally qualified medical practitioner must be obtained.</i></p>

OPTIONAL: LOSS OF INCOME	STUDENT BENEFITS
<p>Loss of Income optional policies may be taken out to cover full time employed participant's.</p> <p>Insurance can be effected on an Association basis.</p> <p>Cover is for 75% of your weekly income or \$250 / week benefit, whichever is the lesser.</p> <p>52 weeks benefit.</p> <p>Excess 14 days per claim.</p>	<p>Pays up to 75% of non medical expenses to a limit of \$1500 being costs incurred for tutoring, travelling costs, etc. (on Doctor's authority) to assist the full time student</p> <p>Excess: 14 days per claim</p>
	PARENTS ALLOWANCE
	<p>Pays up to 75% of non medical expenses to a limit of \$1500 being for home duties etc. (provided by an authorised service).</p> <p>Excess 14 days per claim.</p>

PUBLIC LIABILITY	PROFESSIONAL INDEMNITY
<p>\$10,000,000 Public Liability</p> <p>Insured: Committee officials of the associations/clubs including registered members for their respective rights and liabilities. Cover is Australia wide</p> <p>Policy includes goods sold/care custody control of grounds/buildings</p> <p>Excess \$500 per claim.</p>	<p>\$2,000,000 Professional Indemnity</p> <p>Insured: Accredited coaches/ referees/selectors in performance of their duties.</p> <p>Excess \$500 per claim.</p>

PUBLIC LIABILITY PROCEDURE

Any incident that may give rise to a claim under any contract of Public Liability Insurance should always be referred directly to Sportscover at the earliest possible opportunity

1. Report the incident to "on duty official"
2. Report the incident to Sportscover via;

Sportscover will issue a claim form to the claimant. Further correspondence with the claimant will be handled directly by the insurer

3. Complete the claim form and have the official complete the report section of the claim form.

IMPORTANT

At no time should any representative of the Club / Association admit any liability what so ever for the incident

A detailed report be made of the incident and reported to the relevant Association officer or official

Ensure Witness names and addresses are included in the claim details
